

The meeting must be closed to the public in order to protect confidential commercial and financial information provided to HOC from a PNC Bank, N.A. (a private financial partner) in connection with PNC's provision of various lines of credit to HOC. The information to be discussed is customarily and actually treated as confidential by PNC Bank, N.A. and has been provided to HOC under assurances of privacy.
